

ALASKA WILDERNESS VOYAGES, LLC CHARTER DOCUMENT

MAKING A RESERVATION

Alaska Wilderness Voyages, LLC, hereafter "A.W.V." - requires a \$2500 non-refundable deposit within 10 days of making your reservation. By January 1st of the year of your voyage, 50% of the total trip cost is required. Reservations made after January 1st require 50% of the total trip cost within 10 days after making your reservation. The balance of the total trip cost is due 60 days prior to the charter date. If the reservation is made within 60 days prior to charter date, payment is due in full within 10 days of making your reservation. A deposit as well as a signed charter document is required to confirm your reservation. **There are no exceptions.** The charter document is a written acknowledgment of A.W.V.'s refund and cancellation policies. **Failure to pay final balance by the due date will result in the cancellation of your reservation and no refund will be given.**

Payments can be made by check, money order or bank wire. Please identify all payments clearly with your name, address and trip dates.

CANCELLATION POLICY

If it becomes necessary for you to cancel your reservation, A.W.V. requires written notice of cancellation via certified mail.

REFUNDS

If we receive cancellation notice 61 or more days prior to departure date, 50% of total charter cost will be refunded. If we receive cancellation notice 31-60 days prior to departure date, 25% of total charter cost will be refunded. If we can rebook your scheduled charter with another like cost charter we will gladly refund 80% of the total charter cost. If your charter is rescheduled with a lower cost charter, you will receive a prorated portion.

A.W.V. reserves the right to change or substitute crew members or make changes in our schedule or itinerary when necessary for the safety of our guests. In the unlikely event of mechanical breakdown, we reserve the right to make a timely substitution to another boat of comparable size and quality. If your charter is canceled or length reduced due to mechanical breakdown, we will refund the amount paid to us on a prorated basis. A.W.V. reserves the right to cancel any charter at any time.

INSURANCE

A.W.V. **strongly recommends** that all guests carry Trip Cancellation Insurance, Trip Interruption Insurance and Medical Insurance. These insurance types safeguard you against unforeseen mishaps that can occur before or during your vacation with us. Contact your travel agent for assistance in acquiring travel insurance.

CONTRACT and AGREEMENT DOCUMENT

Trip participants should understand that the marine travel trips involve known and unknown risks. A.W.V. assumes no responsibility for injuries, death, financial losses or damage to clients' property caused by or occurring during participation in any of the travel trips operated by A.W.V. A.W.V. requires that all trip participants acknowledge and assume these risks by reading and signing an A.W.V. Contract and Agreement document prior to departure
